**ORDINANCE NO. 34, SERIES OF 2017**

**AN ORDINANCE ADOPTING AND APPROVING THE UPDATED COMPREHENSIVE LAND USE PLAN (CLUP) OF THE MUNICIPALITY OF ITOYON, PROVINCE OF BENGUET FOR THE PERIOD 2015-2024.**

**WHEREAS**, Section 20 (a) of Republic Act (RA) 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units (LGUs) shall, in conformity with existing laws, continue to prepare their respective Comprehensive Land Use Plans (CLUPs) enacted through Zoning Ordinances (ZOs) which shall be the primary and dominant bases for future use of land resources;

**WHEREAS**, the updated Comprehensive Land Use Plan (CLUP) for 2015-2024 of the Municipality has been prepared;

**WHEREAS**, public consultation meetings were conducted and the same were attended by various inter-agencies of the national government, mining companies, barangay representatives, non-governmental organizations and residents of different barangay units of the Municipality of Itoyon;

**WHEREAS**, the Provincial Land Use Committee, through Resolution No. 17-02 has recommended the adoption and enactment of the proposed Comprehensive Land Use Plan (CLUP) of the Municipality of Itoyon for the period 2015-2024;

**WHEREAS**, after thorough deliberation, it was recommended that the matter be given favorable action;

**NOW, THEREFORE**, on motion of Councilor Dante Alain Xavier D. Godio, unanimously seconded

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF ITOGON, DULY ASSEMBLED DURING ITS SESSION THAT:**

**SECTION 1.** The Updated Comprehensive Land Use Plan (CLUP) of the Municipality of Itogon, Province of Benguet for the period 2015-2024 is hereby adopted and approved.

**SECTION 2. Repealing Clause.** Municipal Resolution Numbered 197, Series of 1999 and all other ordinances, resolutions and regulations or part of parts thereof, which are inconsistent with this Ordinance, are hereby repealed or modified accordingly.

**SECTION 3. Effectivity.** This Ordinance shall take effect pursuant to the provisions of the Local Government Code of 1991.
