**RESOLVED**, as it is hereby done, to enact the following Ordinance, to wit:

**ORDINANCE NO. 08, S.2013**

**AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 13, S.2002 RE: MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES COUNCIL (MENRC).**

**BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Itogon, Benguet in session duly assembled, that:

**SECTION 1.** Section 3 of Ordinance No. 13, s.2002 shall be read as follows:

“**SECTION 3.** Composition: The Council shall be composed the following:

**RESOLUTION NUMBERED 331, S. 2002**

**WHEREAS**, DENR DAO # 30 s. 92 and Joint Memorandum Circular No 98-01 of the DENR and DILG, provide for the policy guidelines and manual procedures for the transfer and implementation of DENR functions devolved to the Local Government Unit,

**WHEREAS**, the Municipality of Itoгон recognizes the need to enhance and strengthen the collaboration and partnership between the LGU and the DENR in the development/management of forest and other natural resources within the jurisdiction of the Municipality;

**NOW, THEREFORE**, on motion of Honorable Michael G. Tauli, seconded by Honorable Gerard S. Comel, be it

**RESOLVED**, as it is hereby resolved, to adopt the following Ordinance, to wit:

**ORDINANCE NO. 13. s. 2002**

**CREATING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES COUNCIL OF THE MUNICIPALITY OF ITOGON AND APPROPRIATING FUNDS THEREFORE.**

**BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Itoгон. Benguel, in session duly assembled, that:

**SECTION 1. TITLE:** This Ordinance shall be known as an Ordinance creating the Municipal Environment and Natural Resources Council.

**SECTION 2. COVERAGE:** The Council shall cover the entire jurisdiction area of the Municipality.

**SECTION 3. COMPOSITION:** The Council shall composed of the following:

**SECTION 4-** The Council shall in itself create a Standing Committee, which shall comprise the following:

1. Committee on Forest Management - Chairman – Members
2. Committee on Protected Areas and Wildlife - Chairman – Members
3. Committee on Environment Management - Chairman- Members
4. Committee on Mines and Geo Sciences - Chairman Members
5. Committee on Land Management - Chairman – Members

**SECTION 5 – FUNCTIONS:** In addition to the functions stated under DENR, DAO # 30, s. 02, the Committee may formulate additional functions applicable to the Focal Government Unit (LGU).

**SECTION 6 – FUNDING:** The Local Government Unit (LGU) of Itogon shall appropriate the necessary funds from any available sources for the smooth and effective performance of the council.

**SECTION 7 –** The Council upon its creation shall adopt their own Internal Rules of Procedure in the conduct of their meetings and other activities.

**SECTION 8 – SEPARABILITY CLAUSE:** If any part or provision of this Ordinance is held unconstitutional or invalid, other part or provision hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 9 - EFFECTIVITY** This Ordinance shall take effect upon approval and remain in force and effect unless otherwise revoked or amended by any competent authority.
